- 2. Poster (100 pts). Graded on quality of photographs, poster-craft, and accuracy.
- 3. Oral Poster Presentation (50 pts). Graded based on oral communication skills.
- 4. Photograph Catolog (20 pts). A digital collection of all of your photos taken each week. Each photo is labeled as per the following example "phaseolus-vulgaris-week01a.jpg". Graded on completeness.
- 5. <u>Voucher Specimens</u> (70 pts). A collection of pressed and dried specimens of seedlings at weekly stages of development. Graded on completeness & quality of specimens and data.
- 6. <u>Participation/Attendance Penalties</u>. You will lose upwards of 5 points per lab period for unexcused absences, late arrivals or early departures, failure to work diligently for the entire lab, failure to clean-up thoroughly after lab, failure to treat equipment and other persons in the lab with due courtesy, or recreational use of phones during lab.
